Horizon Structures LLC 2023 Run-In Shed Giveaway Official Rules

1. Introduction

2. Eligibility

In order to be eligible for the 2023 Horizon Structures LLC Run-In Giveaway, the following criteria must be met:

- Giveaway is open to all legal residents of the 49 Continental United States and D.C., who are over 18 years of age. Void where prohibited or restricted by law.

Prizes are nontransferable and must be accepted as awarded. A cash equivalent may be made to the Grand Prize winner in the event that they live further than 500 miles of Atglen, PA. All additional expenses incurred by the winner, including building permits, service contracts, taxes (if any) are the responsibility of the winner.

7. Site Preparation

Horizon Structures LLC recommends the following site preparations:

All run-in sheds should start with a level pad of stone dust or other fine stone. Ideally, the pad should be 3'' - 4'' deep and 1' larger than the perimeter of the structure. For example: a 10'x20' run-in shed would require a pad at least 12'x22'. Extending the pad will allow for better drainage around the base of the barn. Rain and/or snow melt dripping off the eaves will creates a muddy area and splashes up onto the barn siding. The stone dust base prevents this and extends the life of the building. We recommend stone dust rather than gravel because it is easier on your horse's feet and will shift less as they move around over it.

- To prepare the pad, remove the sod from an area slightly larger than the anticipated structure. Level the site by removing dirt where necessary, and spread the stone dust to a depth of about three or four inches. Using more "fill" to elevate or angle the pad slightly will improve drainage. To finish, tamp the stone dust down with a piece of 4x4, or metal tamper, until it is evenly distributed, flat and level.
- A "frame" of pressure-treated 4x4's (railroad ties or cement block) will help keep the stone in place and create a neater appearance; however, it is not required.

After the shed is in place many people like to backfill the interior with more stone dust or clay. Installing rubber mats over the fill will prevent damage from horses pawing or digging. Because all our buildings have a pressure treated base, they may be set directly on the ground. Run-in sheds are more suited than barns to an unprepared base. There are no doors or windows to jam or stick should the building settle unevenly. Additionally, run-in sheds are often relocated within a pasture or to a different pasture. If this is the case, spending a lot of time and money on site prep doesn't make sense. A dry, level spot will suffice.

However, if you plan on keeping your run-in shed in a permanent location, the stone dust base is a good idea. Horses can churn the inside of their shelter into mud in no time. A stone dust "floor" is less vulnerable to standing water and easier to maintain. Just add more gravel as needed.

Finally, although our <u>run-in sheds</u> are heavy and solidly built, consider tiedowns or an anchor kit for your peace of mind and your horse's safety. The standard built-in tow hooks make it a snap to tie down a building. We also sell anchor kits. Install it yourself or have us do it when we set up your building.

8. Delivery

Horizon Structures LLC will handle delivery of the run-in shed to the winner. Deliveries are normally made Monday through Friday between the hours of 6 am and 6 pm depending on customer location. Mileage is based upon the distance from Horizon Structures LLC's facility, or affiliate facility, to the requested delivery location. Horizon Structures LLC reserves the right to reschedule deliveries due to inclement weather, periods of excessive rain or other events beyond our control. Horizon Structures LLC also asks that the Winner request delivery be rescheduled should the Winner believe inclement weather, soft ground or other conditions exist which would impede the safe delivery of the building or cause damage to the delivery truck or trailer or Winner's property or otherwise make delivery exceptionally difficult for the driver.

Fourteen (14) feet of clearance must be provided to the building site or delivery will be made to the closest acceptable site. Winner understands that the trucks used to deliver buildings are heavy industrial trucks and, therefore, Winner warrants to Horizon Structures LLC that the driveway of Winner is capable of holding the weight of the trucks and loaded trailer. In the event the driveway is damaged despite this warranty by Winner, Winner waives any cause of action against Horizon Structures LLC or its subcontractors for any damage associated with the trucks and trailers of Horizon Structures LLC or its subcontractors. Winner understands that it may be necessary for Horizon Structures LLC or its subcontractors to drive across or through Winner's lawn, pasture or other ground. Winner also waives any course of action against Horizon Structures LLC or its subcontractors for any damage caused to Winner's lawn, pastures, ground, fences, gates, structures, buildings, animals or other property whatsoever. Winner is responsible for towing charges incurred should the delivery truck or trailer become stuck.
